**Sub: Scrutinizer's Report on Postal Ballot conducted through e-voting pursuant to provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 and the physical ballot forms received from shareholders**

I, Shailesh Kachalia, Practising Company Secretary, was appointed as the Scrutinizer by the Board of Directors of Winmore Leasing and Holdings Limited ("the Company") on 18<sup>th</sup> February 2015, pursuant to Section 110 of the Act read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules 2014, to conduct the electronic voting process and to scrutinize the physical ballot forms received from shareholders in respect of the below mentioned resolution to be passed through Postal Ballot.

The Notice dated 18<sup>th</sup> February 2015, for transacting the special business by passing an Ordinary Resolution through Postal Ballot along with a Statement setting out material facts under Section 102 of the Act was sent to the Shareholders in respect of the said resolution.

The Company had availed the e-voting facility offered by National Securities Depository Limited ("NSDL") for conducting e-voting by Shareholders of the Company. The Company had also provided voting by physical ballot papers to its members including those who do not have access to e-voting facility.

The voting period for e-voting commenced on Saturday, February 21, 2015 at 09.00 a.m. and ended on Sunday, March 22, 2015 at 05.30 p.m. The NSDL e-voting platform was thereafter blocked and the votes cast under e-voting facility were then unblocked in the presence of two witnesses who were not in the employment of the Company. Votes cast through Physical Ballot forms received upto March 22, 2015 were considered.

Based on the data downloaded from the NSDL e-voting system and the ballot forms received, I have scrutinized and reviewed the voting through electronic means and physical mode and votes tendered therein.

I now submit my Report as under on the result of the voting through electronic means and physical mode in respect of the said Resolution.
